Details:

All exhibitors serving or working the event **must be at least 21 years of age**. No exceptions!

No hard alcohol is allowed to be brought or served to anyone. Don't risk a \$20,000 fine

Two (2) wristbands will be provided for each exhibitor. We ask that you do not serve anyone until 6pm, unless they are a VIP guest who will be allowed to enter 30 mins prior to the event start. We ask that you only serve guests who have an event wristband (this is a private fundraising event.)

Exhibitors, we cannot do this event without your help and we appreciate you. We understand that you may be hungry and we welcome you to eat and sample; however, we ask that you wait to sample after our guests have arrived. We have over 700 guests at the event and we do not want to run out of food or drink for those who paid.

Exhibitors will be allowed to begin setup at 3pm on Friday June 5th and **must be complete by 5pm** (in time for photos before guests arrive).

Please park in the vendor/exhibitor parking areas.

A packet will be given to you when you arrive at the event with exhibitor information in it.

We will have volunteers to help you unload and take items to your stations; if ice is needed please use the sign that will be in your packet, place on the table and a volunteer or the NRCC staff will help you.

All exhibit items need to be within your station and extra items can be stored under display tables. We ask that you please keep your stations clean at all times.

Tear down and removal of your items will not be allowed before 9:30PM and completed by 10:30PM. Any exhibitor(s) who tear down early risk the chance of not being invited back the following year.

At the end of the event, **trash must be taken out to the large trash trailer** just outside the front patio near the drop off zone.

Fire, Safety, and Health Regulations: All exhibitors agree to comply with local, city, and state laws. Exhibitors agree to immediately comply with any fire, safety, or health request by the Fire Marshall or Event Manager. All Smoking is prohibited.
